***Factory Bridge Preparing for Major Rehabilitation***

Union County has set aside \$1.2 Million for major repairs to Factory/Horsham Bridge (PA-60-04). PennDOT expects the project to start later in 2022. At the May 3, 2022 Union County Commissioners Meeting \$145,002 was approved for "construction inspection services" for Factory Bridge. The 1882 built bridge on Gray Hill Road crossing White Deer Creek was rehabilitated in 1992. The bridge is currently listed in poor condition.

***Progress Continues to Rebuild Honey Run Bridge***

Honey Run Bridge in Butte County, California (CA-04-01x) was destroyed by wildfire on November 8, 2018. In January of 2019 the Honey Run Covered Bridge Association (HRCBA) convinced Butte County they could raise enough funds to rebuild the bridge. Ownership of the bridge was transferred from Butte County to the HRCBA. More than three years later a lot of progress has been made for rebuilding the bridge but there is still a long way to go. Current cost estimate is \$3.2 million. This includes Phase I, \$1.2 million for foundations, abutment, columns and slope protection, Phase II, \$1.3 million for deck and trusses and \$700,000 for Phase III, siding and roof. Through many fundraising efforts \$1.2 million was raised by November of 2020 for Phase I of the plan. Phase I was completed in 2021 and engineering plans are in place for Phase II. HRCBA is hopeful the goal of \$1.3 million will soon be reached and Phase II could begin by the summer of 2022 and Phase III will follow in 2023.
